Willamette MBA Scholarship

The Willamette MBA Global Diversity Scholarship program is for international students who completed their bachelor degree in any of the following countries**: Armenia, Azerbaijan, Bahrain, Brazil, Bulgaria, Chile, China, Colombia, Egypt, Hong Kong, India, Indonesia, Iraq, Israel, Jordan, Kazakhstan, Kuwait, Lebanon, Philippines, Qatar, Romania, Taiwan, Thailand, Turkey, United Arab Emirates, and Vietnam.

Even applicants who do not qualify for a Global Diversity Scholarship will still receive full consideration for merit-based scholarships, based on eligibility. We encourage applicants from all over the world to apply!

Applicants selected for this scholarship will receive a \$5,000 Global Diversity scholarship and an Atkinson School Scholarship of at least \$16,000. Thus, the total scholarship award for an applicant who receives a Global Diversity Scholarship and an Atkinson School Scholarship will range from \$21,000 (57% of tuition) to approximately \$37,000 (100% of tuition).
